DESCRIPTION

The PS7802A-1A is a low output capacitance solid state relay containing a GaAs LED on the light emitting side (input side) and MOS FETs on the output side.

An ultra small flat-lead package has been provided which realizes a reduction in mounting area of about 50% compared with the PS72xx series.

It is suitable for high-frequency signal control, due to its low $C \times R$, low output capacitance, and low off-state leakage current.

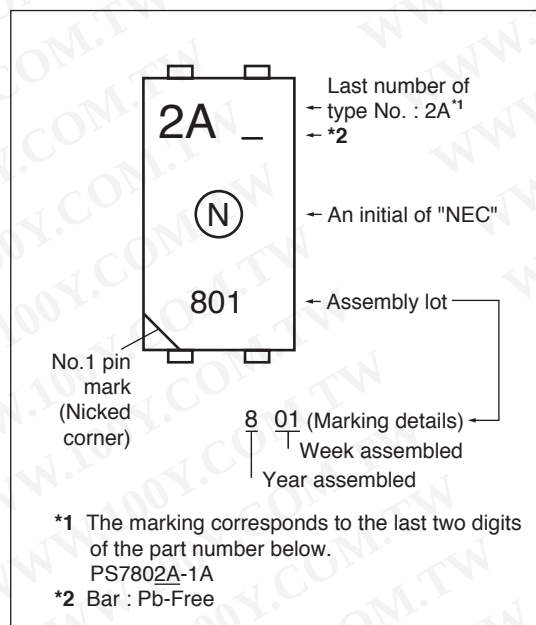

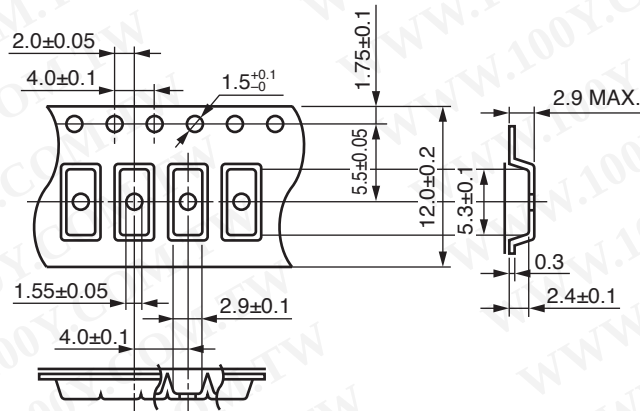

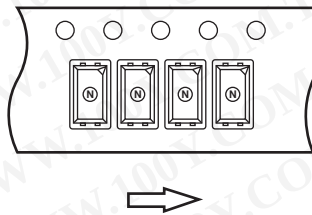

Outline and Dimensions (Tape)

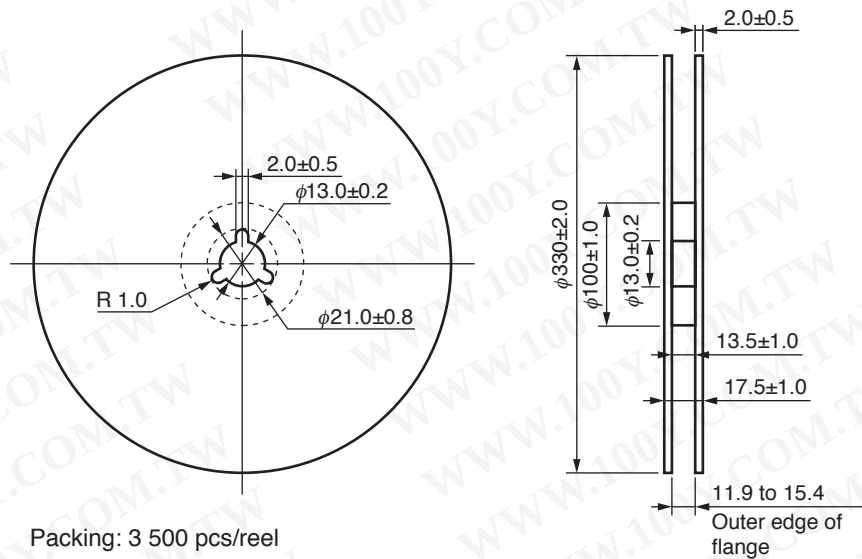


Tape Direction

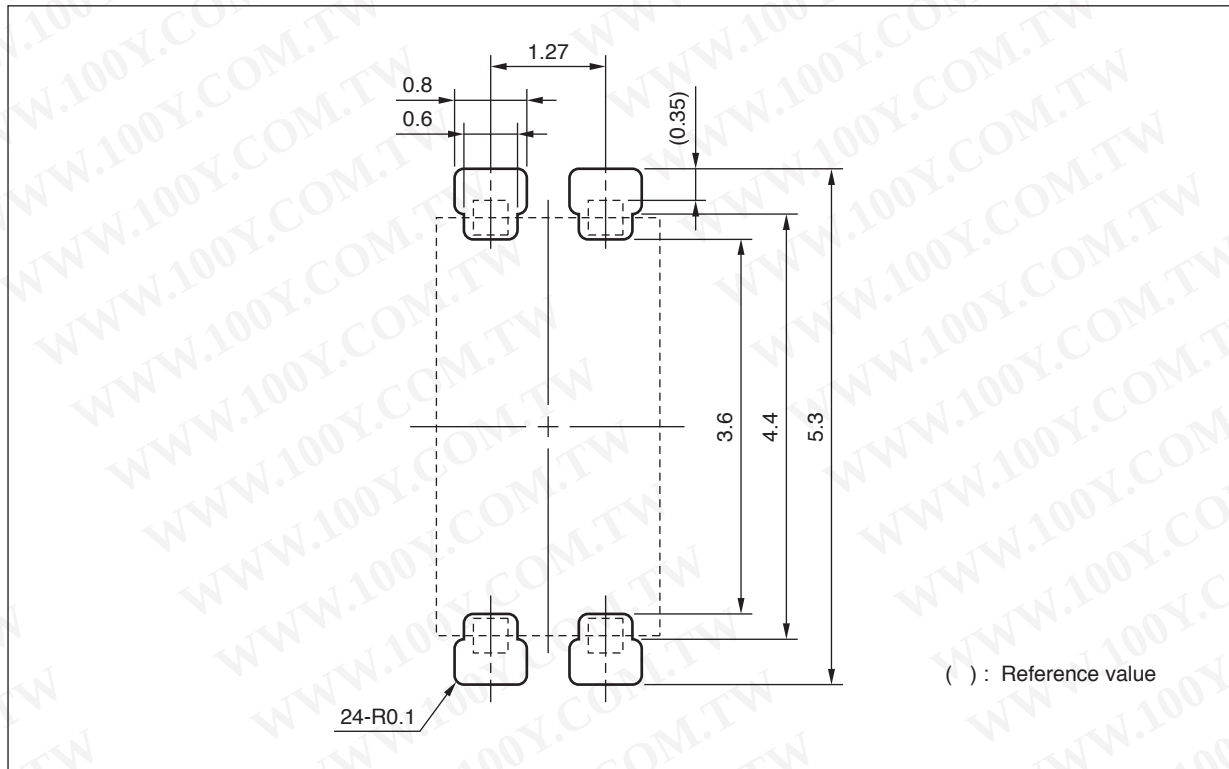


Outline and Dimensions (Reel)

RECOMMENDED MOUNT PAD DIMENSIONS (UNIT: mm)

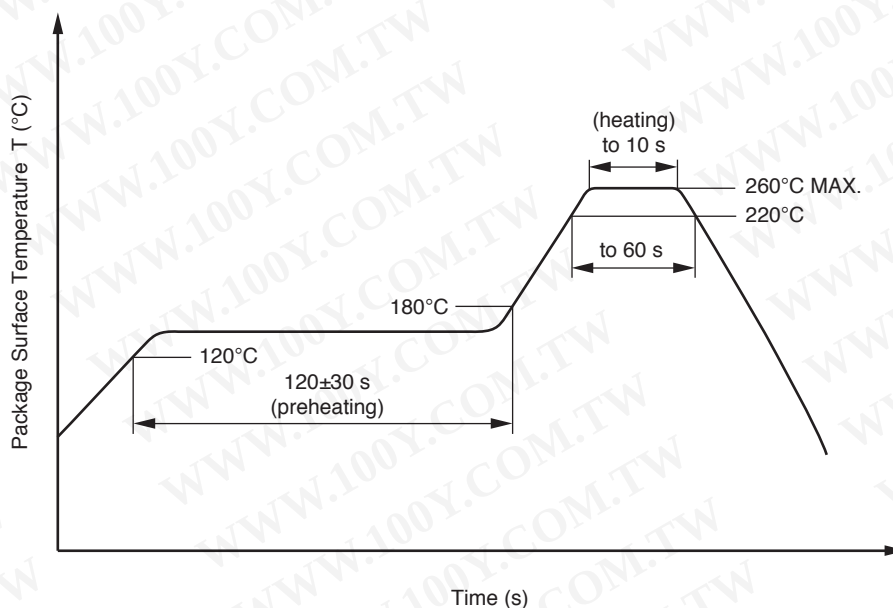
